USNA Alumni Association Board of Trustees Spring Meeting May 3, 2013 Summary

The Board of Trustees met for its regular meeting in Alumni Hall beginning at 0800 on May 3, 2013. ADM Robert J. Natter, '67 USN (Ret.), Chair of the Board of Trustees, acted as chair of the meeting and Commander Lawrence Heyworth, III, '70, USN (Ret.) acted as secretary of the meeting.

The Chair welcomed all and determined that a quorum was present. Trustee Jennifer Stillings, '96 was excused in advance from the Board meeting by ADM Natter.

The following resolutions were adopted by a unanimous vote of the Board of Trustees:
